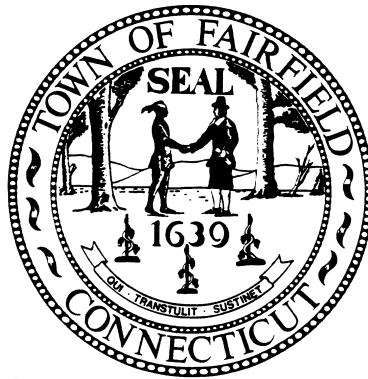

- The physician will be sent a 2-question form to complete, which will be valid for 6 months – 1 year

5.6 Parish Court (comprise of 9 buildings)

- 100 units for up to max occupancy= 160
- 62 or older or Social Security Disabled/income guidelines
- **Generator – Diesel (250 gal tank capacity) - 5 days operation under full load.** Coverage for full operation of Community Center (temporary place of refuge) and standby power for fire alarm system's alarms and monitoring reporting. Apartments' power and site lighting not on generator. Some seniors will need Town transport to Town shelter in time of mandatory evacuation.
- Purchased insurance to provide emergency relocation and temporary lodging for ~60 for up to 6 months.

- 18 and over, income guidelines apply, rent based on the Low Income Housing Tax Credit Program through the CT Housing Finance Authority
- **Generator – natural gas – for community room only**

- 62 or older or have a need for handicapped-adapted unit (only 2 handicapped-adapted units), income guidelines apply

- 24/7 in home care
- Can supplement care at facilities, hospitals, and emergency situations
