The Annual Budget Meeting of the Town of Fairfield will be held via phone on Monday, May 3, 2021, at 8:00 P.M. for the following purposes:

1. Roll Call - Pledge of Allegiance - Moment of Silence
2. To consider and act upon self-supporting funds in the amount of \$5,915,040 for the Water Pollution Control Authority for the Fiscal Year of July 1, 2021 through June 30, 2022.
3. To consider and act upon self-supporting funds in the amount of \$189,100 for the Regional Fire Training School for the Fiscal Year of July 1, 2021 through June 30, 2022.

4. To consider and act upon proposed appropriations in the amount of \$333,361,651 for the Fiscal Year of July 1, 2021 through June 30, 2022, as recommended by the Board of Finance, for any lawful purpose. The total proposed budget as approved by the Board of Finance is as follows:
